A RESOLUTION/ORDINANCE LEVYING GENERAL PROPERTY TAXES FOR THE YEAR  
1990, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE Town  
of Ophur COLORADO, FOR THE 1991 BUDGET YEAR.

WHEREAS, the Town of Ophur of the Ophur Colorado has  
adopted the annual budget in accordance with the Local Government  
Budget Law, on November 20, 1990 and;

WHEREAS, the amount of money necessary to balance the budget for  
General Fund Water Fund  
general operating purposes is \$51555.17, and; 81667.57

WHEREAS, the amount of money necessary to balance the budget for  
bonds and interest is \$ N/A, and;

WHEREAS, the amount of money necessary to balance the budget  
pursuant to Sections 29-1-301(1.2) and 29-1-302(1.5) for capital  
expenditures is \$ N/A, and;

WHEREAS, the 1990 valuation for assessment for the

NOW, THEREFORE, BE IT RESOLVED/ORDAINED BY THE Town of Ophir OF  
THE Ophir COLORADO:

Section 1. That for the purpose of meeting all general operating expenses of the Town of Ophir during the 1991 budget year, there is hereby levied a tax of 14.103 mills upon each dollar of the total valuation for assessment of all taxable property within the County/City/Town/District for the year 1990.

Section ②. That for the purpose of meeting all bonds and interest of the -N/A during the 19 budget year, there is hereby levied a tax of \_\_\_\_\_ mills upon each dollar of the total valuation for assessment of all taxable property within the County/City/Town/District for the year 19.

Section ③. That for the purpose of meeting all the approved capital expenditures of the N/A during the 19<sub>91</sub> budget year, there is hereby levied a tax of \_\_\_\_\_ mills upon each dollar of the total valuation for assessment within the County/City/Town/District for the year 19<sub>91</sub>.

Section 4. That the Town Treasurer is hereby authorized and directed to immediately certify to the County Commissioners of San Miguel County, Colorado, the mill levies for the Town of Ophir as hereinabove determined and set.
