AN ORDINANCE AMENDING THE 1999 BUDGET TO PROVIDE A SUPPLEMENTAL APPROPRIATION AND AUTHORIZING AN EXPENSE FROM AN EXISTING APPROPRIATION FOR THE PURPOSE OF ACQUIRING A WEATHER STATION, AND AUTHORIZING ADDITIONAL AGREEMENTS FOR SUCH PURPOSE

WHEREAS, The Ophir General Assembly has determined that the Town of Ophir is in need of a weather station, and the public health, safety and welfare will be promoted by the acquisition and maintenance of a weather station in the Town of Ophir; and

WHEREAS, Helitrax, Telski, Western Weather Consultants and San Miguel County have agreed to contribute funds for the purchase of the weather station.

NOW THEREFORE, BE IT ORDAINED BY THE GENERAL ASSEMBLY OF THE TOWN OF OPHIR, COLORADO, THAT:

**Section 1: Purchase Authorized**

The Ophir Mayor and Town Clerk are hereby authorized and directed to execute all reasonably necessary and customary documents to purchase the weather station.

**Section 2: Appropriation**

The 1999 Ophir Budget shall be amended to establish a new appropriation line item within the Capital Improvements Fund, referred to as "Weather Station". There is hereby transferred from the Capital Improvements Fund line item for General Construction and Maintenance the sum of \$2,000 for the Weather Station appropriation. All prior transfers from the General Fund to the Capital Improvements Fund are hereby approved and ratified.

**Section 3: Expenditure**

An expense of \$2,000 for the acquisition and maintenance of the weather station is hereby authorized.

**Section 4: License / Lease**

The Ophir Mayor and Town Clerk are authorized to execute a lease or license agreement as necessary to locate the weather station on private property.




