AN ORDINANCE PROVIDING FOR THE VACATING OF CERTAIN UNUSED AND UNIMPROVED ALLEYS AND ROADWAYS IN THE TOWN OF OPHIR, STATE OF COLORADO . Sym

WHEREAS, Certain alleys and roadways appear to have been dedicated to the public use, and have been platted on the recorded plat of the Town of Ophir, State of Colorado; and

WHEREAS, The said alleys and roadways as described in the hereafter contained ordinance, are not presently lawfully used by the public and they are not held for any government purposes of the Town of Ophir, and the Board of Trustees of the Town of Ophir find that the same are not useful to the Town of Ophir or the public for any governmental purpose and that it would be for the best interest of the Town of Ophir to vacate and dispose of the same due to the potential avalanche hazards;

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF OPHIR, STATE OF COLORADO:

SECTION 1: The following described streets and alleys and rights of way or portions thereof are hereby vacated:

> All of Bobtail street lying between Blocks 1 & 2, Ophir, from its northerly intersection with Aurum street, northerly to the Town boundary; The alley within Block 2, Ophir; All of First street lying between Blocks 2 &3, Ophir, from its northerly intersection with Aurum street, northerly to the Town boundary; All of Second street lying between Blocks 3 & 4, Ophir, from its northerly intersection with the alley between Blocks 3 & 4, northerly to the Town boundary: All of Third street lying between Blocks 4 & 5, Ophir, from its northerly intersection with the alley between Blocks 4 &5, northerly to the Town boundary; All of Fourth street lying between Blocks 5 & 6, Ophir, from its northerly intersection with Aurum street, northerly to the Town boundary;

The alley within Block 1, Ophir;

The alley within Block 6, Ophir; All of Fifth street lying between Blocks 6 & 7, Ophir, from its northerly intersection with Aurum street, northerly to the Town boundary;

The alley within Block 7, Ophir;

All of Sixth street lying between Blocks 7 & 8, Ophir, from its northerly intersection with Aurum street, northerly to the Town boundary;

The alley within Block 8, Ophir

All of Seventh street lying between Blocks 8 & 9, Ophir, from its northerly intersection with Aurum Street, northerly to the Town boundary;

SECTION 2: All of the property abutting the aforesaid streets, alleys and rights of way are owned by the Town of Ophir.
