#### **General Assembly Meeting Memorandum**

## 4a. Planning and Zoning Commission Election

There is one candidate for a full P&Z seat: Daniel Forgrave. He is running for a one-year term that would end in July 2024.

### 5a.i Ophir Microgrid/Solar Array update

The San Miguel Power Association (SMPA) was awarded a \$36K planning grant by the Microgrids for Community Resilience program to study the creation of a microgrid for Ophir. SMPA put up a match of \$9k, creating a \$45K budget for such planning. SMPA was also awarded grants to study similar microgrids in Rico, Ridgway and the SMPA main offices.

A microgrid would be based on the Town of Ophir employing a large battery system (about the size of a cargo container) that could give the town 4-6 hours of back-up power in the case of a power outage. Both Ophir and Rico and good candidates for such a system as both towns are at the end of the line with respect to electrical service, and we have no redundant or backup line to provide power. The battery would be charged daily by a 200-250 kW solar array, which SMPA and Town staff are discussing putting on Block 10, an entirely Town-owned block of undeveloped property just west of the Cemetery above East Ophir. Part of the planning will include drawing up mock-ups of what the solar array would look like on that location, but if you drive up to the airport you will see a similar sized array on Tim Erdman's property for comparison. The San Miguel Sheriff's Office has also already installed a similar, though smaller, solar array/microgrid system on the south side of their offices in Ilium Valley.

Siting such an array will require several steps on the part of Ophir, including zoning changes, a GA Resolution tentatively approving such a study on Block 10 and ultimately a lease agreement allowing SMPA to construct an array that will be on the property for a minimum of 25 years. The main benefit to Ophir is the resiliency aspect that will power Ophir should the power go out- it is not expected to have any effect on the bottom line of your current electricity bills, though this could be an item to discuss during planning/negotiations.

Kim Wheels of EcoAction, John Wontrobski, Town Manager will present where the project is currently, answer as many of your questions as we can and will discuss next steps.
