ORDINANCE NO. 2021-14

AN ORDINANCE TO APPROVE AN AGREEMENT WITH GROUND POUNDERS, LLC FOR STREET AND TOWN-OWNED UTILITY INFRASTRUCTURE MAINTENANCE AND IMPROVEMENTS

WHEREAS, Town of Ophir has need for contracted street and town-owned utility infrastructure maintenance and improvements; and

WHEREAS, Town of Ophir shall utilize annually budgeted funds for street and utility maintenance and improvements, which for 20224 consist of the following:

- \$22,000 Road Maintenance
- \$13,500 Snow Removal
- \$15,000 Utility Infrastructure Repair & Maintenance
- \$10,000 Equipment Maintenance
- Allocated fund infrastructure improvements
- Funds shall also be subject to unpredictable weather and unexpected utility repairs; and

WHEREAS, Town of Ophir has solicited and received pricing options from a qualified contractor; and

WHEREAS, Ground Pounders, LLC provided the most qualified options compatible with Town of Ophir budget.

NOW, THEREFORE, BE IT ORDAINED BY THE GENERAL ASSEMBLY OF THE TOWN OF OPHIR, COLORADO that:

SECTION 1. The Town Mayor and Town Clerk are hereby authorized and directed to execute a **Street and Town-Owned Utility Infrastructure Maintenance and Improvements Contract** with Ground Pounders, LLC (the "Contract"), in the form attached hereto. Mayor and Town Manager may approve additional non-substantive changes.

SECTION 2. CONTRACT RATES. The following shall be the contracted rates:

- 1. Utilizing Town Equipment
 - Equipment operator labor = \$50/hr.

2. Utilizing Ground Pounders Equipment
\circ 772BH Grader = \$160/hr.
○ 200C Excavator = \$175/hr.
\circ 120C Excavator = \$160/hr.

\circ 50G Mini X = \$120/hr.
Mack Dump Truck = \$95/hr.

O Approval of the Town Manager prior to use of Contractor's equipment shall be required.
SECTION 3. The Contract may be annually renewed, and Contract Rates may be modified, upon motion and vote by the General Assembly, subject to annual appropriations.
SECTION 4. PUBLICATION. After final adoption, notice of passage shall be published in the manner prescribed by the Town Charter.
SECTION 5. SEVERABILITY. If any one or more sections or parts of this Ordinance is adjudged unenforceable or invalid by a court of competent jurisdiction, such judgment shall not affect, impair, or invalidate the remaining provisions of this Ordinance, the intention being that the various provisions herein are severable.
SECTION 6. EFFECTIVE DATE: This Ordinance shall take effect upon publication of notice of passage.

TOWN OF OPHIR RESOLUTION 2021-16

REQUIRING TOWN OF OPHIR TO REPORT WATER DIVERSION RECORDS FOR WATERFALL GULCH FLUME AND PIPELINE

WHEREAS On August 28, 1989 The Town of Ophir received Absolute Water Rights of .02 cfs for municipal use on the Waterfall Gulch Flume and Pipeline Priority No. 9, with an Appropriation date of January 15, 1894 and an Adjudication date of October 31, 1911.

WHEREAS The Town of Ophir has diverted water from The Waterfall Gulch Flume and Pipeline on an ongoing basis for domestic distribution to the Town of Ophir.

WHEREAS Water rights in Colorado are based upon the principle that a water right is a legal right to beneficially use a portion of the public's water without waste or speculation.

WHEREAS Beneficial use of water is not only a requirement for initial appropriation, but an ongoing obligation to maintain a water right.

WHEREAS The Colorado Division of Water Resources, which includes the State Engineer, Division Engineers and Water Commissioners, has the authority to administer all surface water and Denver Basin, tributary and non-tributary groundwater in the state of Colorado.

WHEREAS The Division 4 District 60 Water Commissioner and his or her staff are required to maintain records of the diversion and beneficial use of water.

THEREFORE, BE IT RESOLVED BY THE OPHIR GENERAL ASSEMBLY:

SECTION 1. The General Assembly requires the Town of Ophir to provide Water Diversion records for Waterfall Gulch Flume and Pipeline and all municipal sources of water as recorded at the Town Water Treatment Plant to the Division 4 District 60 Water Commissioner on a monthly basis.
