b) Ordinance 2024-01 for amended 2024 budget John Humphries motions, Janice seconds. Approved via unanimous vote c) Budget- Second Reading- Vote on Resolution 2024-03 Sue asks why there's a \$5k increase in the land stewardship fun.

John Humphries responds work by Bee Happy is important for sustainability and land preservation – and costs about \$3k/month during summer working season. That includes burn area cleanup, weeding, seeding, and other work.

Tyler notes OEC has discussed and agreed to keep the budget at this level. Ophir is prioritizing land stewardship.

Joan asks if there's any difference in the budget from the first reading.

Cindy responds there is a new line item for the town backhoe. We can use the Covid funds for the purchase. RETT has been moved into the reserve fund to gather interest. Funds for the backhoe have been moved into the general fund.

Cindy is adding a budget item for greenhouse improvements, town hopes some grant funding is available. Annabelle is leading the project. Funds will come from the general fund.

Janice asks if it wasn't in the first reading is it fair to the GA.

John Wontrobski notes information was in the GA meeting packet and items are allowed to be added or changed for the second reading.

Tyler motions to approve budget with greenhouse funding, John Humphries seconds.
